For those looking to do something fast, easy, and confidential to stand up for the individuals and agencies that serve and support the most vulnerable members of our community, while practicing and modeling social distancing, may I suggest taking a few minutes to fill out your 2020 Census questionnaire? An accurate census count helps determine how federal dollars are allocated every year to our communities, and this will be critical to the economic and social recovery of North Adams, Berkshire County, and Massachusetts that the COVID-19 pandemic will require. Supporting our residents

Beginning Thursday March 19, the North Adams Stop and Shop will be open 6:00 to 7:30 a.m. daily to serve customers age 60 and older in a less crowded environment, effectively allowing the process of social distancing to be used. In North Adams, the designated entry during these service hours will be on the produce side of the building, that is, the front door on the left. Store employees will not check identification at the door but they ask people to respect the purpose of the early opening.

Supporting small businesses

The Baker-Polito Administration announced today that the U.S. Small Business Administration (SBA) will offer low-interest federal disaster loans to Massachusetts small businesses suffering substantial economic injury as a result of COVID-19. Small businesses, private non-profit organizations of any size, small agricultural cooperatives and small aquaculture enterprises that have been financially impacted as a direct result of the COVID-19 since January 31, 2020, may qualify for Economic Injury Disaster Loans of up to \$2 million to help meet financial obligations and operating expenses which could have been met had the disaster not occurred. Applicants may apply online, receive additional disaster assistance information and download applications at https://disasterloan.sba.gov/ela. Applicants also may call SBA's customer service center at (800) 659-2955 or email disastercustomerservice@sba.gov.
